

ORDINANCE NO. 1104

AN ORDINANCE OF THE CITY OF CHULA VISTA, AMENDING  
SUBSECTION (c) OF SECTION 2.95 OF THE CHULA VISTA  
CITY CODE, RELATING TO FEES FOR STANDARD  
SPECIFICATIONS AND DRAWINGS

The City Council of the City of Chula Vista does ordain as follows:

SECTION I: That subsection (c) of Section 2.95 of the Chula Vista City Code be, and the same is hereby amended to read as follows:

(c) Engineering Department. The City Engineer is hereby authorized to furnish any person applying therefor any of the following documents, papers, drawings or official records of the Engineering Department upon payment of the fees herein established:

Bid Documents: \$3.00 for complete plan and specifications plus \$ .50 per plan sheet in excess of five (5) sheets.

Aerial topo sheets: \$5.00 per sheet plus \$ .75 per additional copy of same sheet.

Various master street and sewer maps and miscellaneous drawings: \$ .30 per square foot, with a minimum fee of \$1.50.

Xerox reproductions of Engineering documents or correspondence: \$ .75 per sheet.

Standard Drawings: \$2.50 per set or \$ .25 per sheet.

Standard Specifications: \$1.50 per set.

Linen Title Sheet Blank: \$2.00 per sheet.

Linen Title Sheet Profile: \$3.00 per sheet.

Vellum Title Sheet Blank: \$ .50 per sheet.

Vellum Title Sheet Profile: \$1.00 per sheet.

Annexation plats and legal descriptions: \$ .30 per square foot, with a minimum fee of \$1.50.

SECTION II: This ordinance shall take effect and be in full force on the thirty-first day from and after its passage and approval.
