AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING ORDINANCE NO. 1339 BY RENUMBERING CHAPTER 30 OF ARTICLE III, SECTIONS 30.13 THROUGH 30.31 OF THE CHULA VISTA CITY CODE TO CHAPTER 7, ARTICLE 3, SECTIONS 7.301 THROUGH 7.319, RESPECTIVELY, OF THE CHULA VISTA CITY CODE, AND AMENDING SAID NEW SECTION 7.303, ALL RELATING TO IMPOSING A TAX UPON THE PRIVILEGE OF TRANSIENT OCCUPANCY AND PROVIDING FOR THE COLLECTION THEREOF

The City Council of the City of Chula Vista does ordain as follows:

SECTION I: That Chapter 30, Article III, Sections 30.13 through 30.31 of the Chula Vista City Code be, and the same are hereby renumbered to Chapter 7, Article 3, Sections 7.301 through 7.319, respectively.

SECTION 2: That Chapter 7, Article 3, Section 7.303, as herein renumbered, be and the same is hereby amended to read as follows:

Sec. 7.303. Tax Imposed.

For the privilege of occupancy in any hotel, each transient is subject to and shall pay a tax in the amount of six percent (6%) of the rent charged by the operator. Said tax constitutes a debt owed by the transient to the City which is extinguished only by payment to the operator or to the City. The transient shall pay the tax to the operator of the hotel at the time the rent is paid. If the rent is paid in installments, a proportionate share of the tax shall be paid with each installment. The unpaid tax shall be due upon the transient's ceasing to occupy space in the hotel. If for any reason the tax due is not paid to the operator of the hotel, the Director of Finance may require that such tax shall be paid directly to the Director of Finance of the City of Chula Vista.

SECTION 3: This ordinance shall take effect and be in full force on the thirty-first day from and after its passage and approval. Said tax to be imposed as of August 1, 1973.
