

ORDINANCE NO. 1591

AN ORDINANCE OF THE CITY OF CHULA VISTA STIPULATING THAT ORDINANCE NO. 1409 ADOPTS THE 1971 UNIFORM ELECTRICAL CODE AND AMENDS CHAPTER 12, SECTIONS 12.26 AND 12.26.1 AND SUPERSEDES COMPARABLE PROVISIONS HERETOFORE ADOPTED BY ORDINANCES NOS. 943, 975, 994, 1059, 1079 AND 1194; PROVIDED, FURTHER, THAT SECTIONS 12.2, 12.3, 12.9, 12.10, 12.11, 12.12, 12.17, 12.18, 12.19, 12.20, 12.23, 12.24, 12.28, 12.33, 12.49 AND 12.50 BE, AND THE SAME ARE HEREBY RETAINED AS CONTAINED IN ORDINANCE NO. 1194, AND THAT SECTIONS 12.1, 12.14, 12.26, 12.29, 12.36 THROUGH 12.42, AND SECTIONS 12.44 THROUGH 12.48 BE, AND THE SAME ARE HEREBY REPEALED, ALL RELATING TO THE ADOPTION OF THE UNIFORM ELECTRICAL CODE AND FEES FOR ELECTRICAL INSTALLATIONS

The City Council of the City of Chula Vista does hereby ordain as follows:

SECTION I: That Ordinance No. 1409 adopts the 1971 Uniform Electrical Code and amends Chapter 12, Sections 12.26 and 12.26.1, and supersedes comparable provisions heretofore adopted by Ordinances Nos. 943, 975, 994, 1059, 1079 and 1194; provided, further, that Sections 12.2, 12.3, 12.9, 12.10, 12.11, 12.12, 12.17, 12.18, 12.19, 12.20, 12.23, 12.24, 12.28, 12.33, 12.49, 12.50 be, and the same are hereby retained as contained in Ordinance No. 1194, and that Sections 12.1, 12.14, 12.26, 12.29, 12.36 through 12.42, and 12.44 through 12.48 be, and the same are hereby repealed, all relating to the adoption of the Uniform Electrical Code and fees for electrical installation.

SECTION II: IT IS FURTHER ORDAINED that said Ordinance No. 1409 adopts the 1971 Uniform Electrical Code repealing any inconsistent provisions of the 1961 Chula Vista City Code, and further provides that the fees as set forth in Ordinance No. 1386 be, and the same are hereby to remain in full force and effect and that all provisions of Ordinance No. 1194, except as hereinabove listed in Section I, also remain in full force and effect until amended.

SECTION III: This ordinance shall take effect and be in full force and effect on the thirty-first day from and after its adoption.
