## ORDINANCE NO. 1602

AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING SECTION 18.58 OF CHAPTER 18 OF THE CHULA VISTA CITY CODE RELATING TO BUSINESS LICENSE FEES CHARGED TO PROFESSIONAL PERSONS

The City Council of the City of Chula Vista does ordain as follows:

SECTION I: That Section 18.58 of Chapter 18 of the Chula Vista City Code be, and the same is hereby amended to read as follows:

## Sec. 18.58 Professions.

Every person conducting, managing, carrying on or engaged in any business hereinafter enumerated in this Section shall pay a license fee of twenty-five dollars (\$25.00) per annum:

- 1. Accountant.
- 2. Appraiser.
- 3: Assayer.
- 4. Attorney at law.
- 5. Auditor.

- Bonds--fidelity, indemnity, faithful performance or bail.
- 7. Chemist.
- 8. Chiropodist.
- 99. Chiropractor.
- 10. Dentist.
- 11. Engineer--civil, electrical, chemical or mechanical.
- 12. Newspaper publisher.
- 13. Oculist.
- 14. Ophthalmologist.
- 15. Optometrist.
- 16. Optician.
- 17. Osteopath and Osteopathist.
- 18. Pharmacist.
- 19. Physician.
- 20. Physiotherapist.

- 21. Podiatrist.
- 22. Psychiatrist.
- 23. Psychologist.
- 24. Real Estate Broker.
- 25. Stocks and bonds--federal, state, county or municipal stocks and bonds, or stocks or bonds of incorporated companies, or evidences of indebtedness of private persons or of incorporated companies.
- 26. Surgeon.
- 27. Veterinarian.

Each professional person mentioned above, whether or not required to be licensed as such by the state to carry on his profession, shall, each individually, whether or not operating as an individual, partnership or associate, pay such license fee; provided, further, that if such professional person mentioned above should be an employee of a professional corporation, said professional person shall pay the same license fee as required herein, but the corporation shall not be required to pay any license fee.

SECTION II: This ordinance shall become effective upon its first reading and adoption if passed by at least four (4) affirmative votes of the City Council as an emergency measure.
