

ORDINANCE NO. 1605

AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING CHAPTER 19 OF THE CITY CODE BY REESTABLISHING THE CONTENT OF SCHEDULE VII RELATING TO THROUGH TRUCK ROUTES

The City Council of the City of Chula Vista does ordain as follows:

SECTION I: That Schedule VII of Chapter 19 of the City Code of the City of Chula Vista be, and the same is hereby amended by adding thereto the following through truck routes:

SECTION II: A violation of any provision or the failure to comply with any of the requirements of this ordinance shall constitute a misdemeanor. Any person convicted of such violation or such failure shall be punishable by a fine of not more than \$500.00 or by imprisonment in the County jail for a period of not more than six months, or by both such fine and imprisonment.

SECTION III: This ordinance shall take effect and be in full force on the thirty-first day from and after its passage and approval.
