ORDINANCE NO. 1628

AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING SECTION 6.24.040 OF THE CHULA VISTA CITY CODE RELATING TO IMPOUND AND BOARDING FEES OF DOGS

The City Council of the City of Chula Vista does hereby ordain as follows:

SECTION I: That Section 6.24.040 of the Chula Vista City Code be, and the same is hereby amended to read as follows:

> Sec. 6.24.040. Impoundment-Notice Required-Disposition of Dogs.

Every dog impounded under this chapter shall be destroyed, sold at private sale or given away by the poundmaster if not claimed and taken away by the owner, and if an impounding fee of five dollars is not paid within three days, plus a fee for boarding and keeping such dog at the rate of one dollar per day or fractional part thereof. It shall be the duty of the poundmaster to destroy, sell at private sale or give away any dog impounded under this chapter within twenty days of the time the same was impounded unless the same was claimed, taken away and the impounds for the above provided for is paid. It shall be the duty of the poundmaster within twenty-four hours to attempt to notify, personally or by mail, the owner of any dog bearing the metal tag or plate mentioned in Section 6.20.070.

SECTION II: This ordinance shall take effect and be in full force on the thirty-first day from and after its adoption.
