AN ORDINANCE OF THE CITY OF CHUIA VISTA, CALIFORNIA, AMENDING ORDINANCE NO.
163 OF SAID CITY, ENTITLED, "AN ORDINANCE OF THE CITY OF CHUIA VISTA, CALIFORNIA
PROVIDING FOR THE CREATION IN SAID CITY OF FIVE(5) ZONES, COMBISTING OF VARIOUS DISTRICTS, AND PRESCRIBING THE CLASSES OF BUILDINGS, STRUCTURES AND IMPROVEMENTS IN SAID SEVERAL ZONES AND THE USES THEREOF; DEFINING THE TERMS USED HEREIN. PRESCRIBING THE REMALTY FOR THE VICLATION OF THE PROVISIONS NEEDER AND RE-PEALING ANY CRDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERENITH". BY CHANG-ING A FORTION OF LOT 2 IN QUARTER SECTION 140 OF SAID CITY, FROM "A" ZOME TO "C" ZOME IN SAID CITY, AND LIKENISE CHANGING A PORTION OF LOT 30 IN QUARTER SEC-TION 139, OF SAID CITY. The City Council of the City of Chula Vista California do ordain as follows:

SECTION I. That Ordinance No. 163 of the City of Chula Vista, California,

entitled, "AN ORDINANCE OF THE CITY OF CHULA VISTA, CALIFORNIA, PROVIDING FOR THE CREATION IN SAID CITY OF FIVE(5) ZONES, CONSISTING OF VARIOUS DISTRICTS, AND PRESCRIBING THE CLASSES OF PUILDINGS, STRUCTURES AND INPROVEMENTS IN SAID SEVERAL ZONES AND THE USES THEREOF; DEFINING THE TERMS USED HAREIN, PRESCRIBING THE PEAMALTY FOR THE VIOLATION OF THE PROVISIONS HEREOF AND REPEALING ANY ORDINANCES OF PARTS OF ORDINANCES IN CONFLICT HERENITH" passed and adopted by the Board of Trustees of said City of Chula Vista on the 8th.day of March, 1927

be and is hereby amended by changing and making Section I4 thereof to be and \_to read as follows: Section I4. The zone boundaries and lines shall be and are hereby made fixed and established , as shown and delineated by the legend of and on the "Zoning Map of the City of Chula Vista, California," which is hereby referred to for a particular description thereof and hereby made a part of this ordinance and said legend of and on the "Zoning Map of the City of Chula Vista, California", and said "Zoning Map of the City of Chula Vista,

California", be and is hereby changed and made to be that, and so that the westerl: 1322 feet and Southerly 135 feet of the westerly 265, 56 feet of Lot 30, Luder Section 34, Mortherly 135 feet and the Easterly 135 feet of Lot 2 in Quarter Section 140

of Chula Vista, in the City of Chula Vista, County of San Diego, State of California according to Map thereof No. 505 filed in the office of the County Recorder of said County, March, 13, 1888, is removed from and no longer a part of "A" Zone of said "Zoning Map of the City of Chula Vista, California" and is hereby placed in and made a part of "C" Zone in said "Zoning Map of the City of Chula Vista, California" and said legend and Zoning Map is hereby changed accordingly. In unsubdivided property, the zone boundary lines on said Zone Map shall be determined by the scale contained on such map, and where uncertainty exists the zone boundary line shall be determined by the City Planning Commission upon written application from said Zone Map, and the records thereof kept on file in the office of the City Planning Commission. SECTION 2. This Ordinance shall take effect and be in force 3I days after its

passage and approval.

SECTION 3. The City Clerk of said City is hereby instructed to cause this Ordinance to be published once in the Chula Vista Star, a weekly newspaper printed and published in and of general circulation in said City of Chula Vista California.
