ORDINANCE NO. 1886

AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING CHAPTER 2.04 OF THE CHULA VISTA MUNICIPAL CODE BY AMENDING SECTION 2.04.580 RELATING TO COMPENSATION FOR MEMBERS OF THE CITY COUNCIL AND ADDING THERETO A NEW SECTION 2.04.590 RELATING TO COMPENSATION FOR THE MAYOR

The City Council of the City of Chula Vista does ordain as follows:

SECTION I: That Chapter 2.04 of the Chula Vista Municipal Code be, and the same is hereby amended by amending Section 2.04.580 and adding thereto a new Section 2.04.590 to read as follows:

Sec. 2.04.580 Councilmembers - Compensation.


The members of the City Council shall receive the sum of four hundred forty-eight dollars and ninety-six cents (\$448.96) per month as compensation for their services, as provided in Section 36516.2 of the Government Code of the State of California, which salary shall be payable from and after the first pay period in January of 1980 in the same manner as the salaries paid to other officers and employees of the the City to and until Section 36516 et seq. of the Government Code of the State of California may be amended, and the City Council amends this ordinance in accordance with such amendments or in accordance with Section 36516.2 of the Government Code providing for annual cost of living increases.

Sec. 2.04.590 Mayor - Compensation.

The Mayor of the City of Chula Vista shall receive the sum of one thousand fifty dollars and no cents (\$1,050.00) per month as compensation for the Mayor's services as provided in Section 304 of the Charter of the City of Chula Vista which shall be payable from and after the first pay period in January of 1980 in accordance with Section 36516.2 of the Government Code of the State of California as it presently reads or as it may be amended providing for annual cost of living increases.

SECTION II: This ordinance shall take effect upon first reading and adoption if passed by at least four (4) affirmative votes.
