


ORDINANCE NO. 1909

AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING SECTIONS 2.36.010 AND 2.36.030 OF THE CHULA VISTA MUNICIPAL CODE ENLARGING THE RESPONSIBILITY OF THE HUMAN RELATIONS COMMISSION TO INCLUDE AN ADVISORY FUNCTION REGARDING THE IMPLEMENTATION OF MASS TRANSPORTATION WITHIN THE CITY

By a unanimous vote on May 13, 1980, the City Council adopted the ordinance and placed it on its second reading and adoption.

The added duties of the Human Relations Commission will be to (1) consider Chula Vista Transit operational items; (2) assess the Transit service from the standpoint of the citizen; (3) consider and recommend levels of service. ORDINANCE NO. 1909

AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING SECTIONS 2.36.010 AND 2.36.030 OF THE CHULA VISTA MUNICIPAL CODE ENLARGING THE RESPONSIBILITY OF THE HUMAN RELATIONS COMMISSION TO INCLUDE AN ADVISORY FUNCTION REGARDING THE IMPLEMENTATION OF MASS TRANSPORTATION WITHIN THE CITY

The City Council of the City of Chula Vista does hereby ordain as follows:

SECTION I: That Subsection B of Section 2.36.010 of the Chula Vista Municipal Code is hereby amended and a new Subsection C is added to read as follows:

Sec. 2.36.010 Purpose and Intent.

- B. It is a further duty and function of the Human Relations Commission to advise the City Council on matters involving Chula Vista Transit relating to operational activities and especially as to how well Chula Vista Transit serves the needs of Chula Vista citizens.
- C. It is the intent of the City Council to create healthy, enlightened attitudes, policies and practices by establishing this commission as an official body, not primarily as an enforcement or audit agency, but as a commission which will conduct careful surveys, advise intelligently, and use the tools of education and motivation to the realization of the objectives stated herein, which are the fulfillment of democracy's promises and the realization of constitutional guarantees.

SECTION II: That Subsection M of Section 2.36.030 of the Chula Vista Municipal Code is hereby amended and new Subsections N, O, and P are added to read as follows:

Sec. 2.36.030 Duties and Functions.

- M. Consider Chula Vista Transit operational items including, but not limited to, route structures; fares; condition of buses; interface with all other forms of transit and bench, bus stop and bus shelter locations.
- N. Assess Chula Vista Transit Service from the standpoint of the Chula Vista citizen and keep the City Council informed of the adequacy of service.
- O. Consider and recommend to the City Council the levels of service of Chula Vista Transit.
- P. The commission shall be advisory in its function, and shall have no police or enforcement powers. It shall issue no reports or recommendations except through the City Council and the City Manager.

SECTION III: This ordinance shall take effect and be in full force on the thirty-first day from and after its passage.
