

ORDINANCE NO. 1960

AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING SECTION 10.62.010(B) OF CHAPTER 10.62 OF THE CHULA VISTA MUNICIPAL CODE RELATING TO PARKING FEES FOR THE PURPOSE OF REGULATING THE USE OF STREETS

The City Council of the City of Chula Vista does hereby ordain as follows:

SECTION I: That Section 10.62.010 of Chapter 10.62 of the Chula Vista Municipal Code be, and the same is hereby amended to read as follows:




