ORDINANCE NO. 1998

AN ORDINANCE OF THE CITY OF CHULA VISTA ESTABLISHING A PRIMA FACIE SPEED LIMIT OF 35 & 45 MILES PER HOUR ON TELEGRAPH CANYON ROAD

The City Council of the City of Chula Vista does ordain as follows:

SECTION I: That Schedule X of Chapter 10 of the City Code of the City of Chula Vista be, and the same is hereby amended by adding thereto the following prima facie speed limit regulation.

Name of Street	Beginning At	Ending At	Speed Limit
Telegraph Canyon Road	I-805	Oleander Ave.	35 mph
Telegraph Canyon Road	Oleander Ave.	Old Telegraph Canyon Road	45 mph

SECTION II: A violation of any provision or the failure to comply with any of the requirements of this ordinance shall constitute a misdemeanor. Any person convicted of such violation or such failure shall be punishable by a fine of not more than \$500.00 or by imprisonment in the County jail for a period of not more than six months, or by both such fine and imprisonment.

SECTION III: The prima facie speed limit declared in this ordinance shall take effect and be in force on the thirty-first day from and after its passage and approval, or as soon thereafter as appropriate signs giving notice thereof are erected upon the street particularly described herein.
