## ORDINANCE NO. 2014

AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING CHAPTER 2.04 OF THE CHULA VISTA MUNICIPAL CODE BY AMENDING SECTION 2.04.580 RELATING TO COMPENSATION FOR MEMBERS OF THE CITY COUNCIL

The City Council of the City of Chula Vista does ordain as follows:

SECTION I: That Section 2.04.580 of Chapter 2.04 of the Chula Vista Municipal Code be, and the same is hereby amended to read as follows:

Sec. 2.04.580

Councilmembers - Compensation.

The members of the City Council shall receive the sum of five hundred nineteen dollars and seventy-three cents (\$519.73) per month as compensation for their services, as provided in Section 36516.2 of the Government Code of the State of California, which salary shall be payable from and after the first pay period in January of 1983 in the same manner as the salaries paid to other officers and employees of the City to and until Section 36516 et seq. of the Government Code of the State of California may be amended, and the City Council amends this ordinance in accordance with such amendments or in accordance with Section 36516.2 of the Government Code providing for annual cost of living increases.

SECTION II: This ordinance shall take effect and be in full force on the thirty-first day from and after its passage.

SECTION III: That the City Council does hereby appropriate \$570 from the unappropriated balance of the General Fund to Council Salary Account 100-105-5101 to cover said increase.
