ORDINANCE NO. 2024

AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING SECTIONS 10.52.090 AND 10.64.010 OF THE CHULA VISTA MUNICIPAL CODE RELATING TO PARKING OF COMMERCIAL VEHICLES IN RESIDENTIAL AREAS

The City Council of the City of Chula Vista does ordain as follows:

SECTION I: That Sections 10.52.090 and 10.64.010 of the Chula Vista Municipal Code be, and the same are hereby amended to read as follows:

Section 10.52.090 Commercial vehicles - Parking in residential districts prohibited when.

No person shall park any commercial vehicle having a manufacturer's gross vehicle weight rating of 10,000 pounds or more for more than five hours in any residential district except:

- A. While loading or unloading property, which requires time in addition to such five hour period to complete such work; or
- B. When such vehicle is parked in connection with, and in aid of, the performance of a service to or on property in the block in which such vehicle is parked and time in addition to such five hour period is reasonably necessary to complete such service.

Section 10.64.010 Compliance required when.

Whenever the City Council establishes by resolution, and when signs have been erected giving notice thereof, no person shall operate any vehicle with a gross weight in excess of 10,000 pounds at any time, except upon the streets or parts of streets described in Section 10.64.040 and Schedule VII attached to and made a part of this chapter.

SECTION II: This ordinance shall take effect and be in full force on the thirty-first day from and after its adoption.
