## ORDINANCE NO. 2077

AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING CHAPTER 1.20 OF THE CHULA VISTA MUNICIPAL CODE RELATING TO THE AMOUNT OF THE FINE FOR INFRACTIONS

The City Council of the City of Chula Vista does ordain as follows:

SECTION I: That Section 1.20.010 of Chapter 1.20 of the Chula Vista Municipal Code be, and the same is hereby amended as follows:

Section 1.20.010 Designated-Applicability.

- A. Any person violating any of the provisions or failing to comply with any of the mandatory requirements of the ordinances of the city shall be guilty of an infraction. An infraction is punishable by:
  - 1. A fine not exceeding one hundred dollars for a first violation;
  - A fine not exceeding two hundred dollars for a second violation of the same ordinance within one year;
  - 3. A fine not exceeding five hundred dollars for each additional violation of the same ordinance within one year.
- B. Each such person shall be guilty of a separate offense for each and every day during any portion of which any violation of any provision of the ordinances of the city is committed, continued or permitted by any such person, and he shall be punished accordingly.
- C. This section shall supersede all other penalty sections in the Chula Vista Municipal Code and any other city ordinances.
- D. Payment of a fine shall not excuse payment of any fee required by the Municipal Code.

SECTION II: This ordinance shall take effect and be in full force on the thirty-first day from and after its adoption.

## ORDINANCE NO. 2077

AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING CHAPTER 1.20 OF THE CHULA VISTA MUNICIPAL CODE RELATING TO THE AMOUNT OF THE FINE FOR INFRACTIONS

By a unanimous vote on August 14, 1984, (Council-woman McCandliss was absent), the City Council placed the ordinance on second reading and adoption.

Chula Vista Municipal Code Section 1.20.010 establishes the penalty for a violation of the Code. The present penalty is \$50 for the first violation, \$100 for the second violation and \$250 for each subsequent violation. The proposed amendment to the Code will increase these maximums to \$100 for the first violation, \$200 for the second violation and \$500 for the third and each subsequent violation. These amounts were increased by the adoption of Chapter 1092, Statutes 1983.
