ORDINANCE NO. 2081

AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING SECTIONS 5.62.010 AND 8.20.020 OF THE CHULA VISTA MUNICIPAL CODE RELATING TO LICENSING OF VENDING VEHICLES

The City Council of the City of Chula Vista does ordain as follows:

SECTION I: That Section 5.62.010 of Chapter 5.62 of the Chula Vista Municipal Code is hereby amended to read as follows:

Sec. 5.62.010 Vending Vehicles - License Fee Required.

Every person conducting, managing or operating a business in which vending vehicles are used, from which any goods other than foodstuffs are sold, given away, displayed or offered for sale at retail, shall pay a license fee of two hundred dollars per year per vending vehicle, payable quarterly. The license shall identify the particular vehicle to be used and shall be kept on the vehicle, available for inspection at all times.

SECTION II: That Section 8.20.020 or Chapter 8.20 of the Chula Vista Municipal Code is hereby amended to read as follows:

Sec. 8.20.020 Vending Vehicles - For Foodstuffs - License fee required.

Every person conducting, managing or operating a business in which carts, wagons or vending vehicles for foodstuffs, including ice cream, are used, shall pay a license fee of two hundred dollars per annum per cart, wagon or vending vehicle, payable quarterly. The license shall identify the particular vehicle to be used and shall be kept on the vehicle, available for inspection at all times.

SECTION III: This ordinance shall take effect and be in full force on the thirty-first day from and after its adoption.

ORDINANCE NO. 2081

AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING SECTIONS 5.62.010 AND 8.20.020 OF THE CHULA VISTA MUNICIPAL CODE RELATING TO LICENSING OF VENDING VEHICLES

The City Council of the City of Chula Vista does ordain as follows:

SECTION I: That Section 5.62.010 of Chapter 5.62 of the Chula Vista Municipal Code is hereby amended to read as follows:

Sec. 5.62.010 Vending Vehicles - License Fee Required.

Every person conducting, managing or operating a business in which vending vehicles are used, from which any goods other than foodstuffs are sold, given away, displayed or offered for sale at retail, shall pay a license fee of two hundred dollars per year per vending vehicle, payable quarterly. The license shall identify the particular vehicle to be used and shall be kept on the vehicle, available for inspection at all times.

Sec. 8.20.020 Vending Vehicles - For Foodstuffs - License fee required.

Every person conducting, managing or operating a business in which carts, wagons or vending vehicles for foodstuffs, including ice cream, are used, shall pay a license fee of two hundred dollars per annum per cart, wagon or vending vehicle, payable quarterly. The license shall identify the particular vehicle to be used and shall be kept on the vehicle, available for inspection at all times.

SECTION III: This ordinance shall take effect and be in full force on the thirty-first day from and after its adoption.
