## ORDINANCE NO. 2097

AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING SECTION 10.62.010B OF THE CHULA VISTA MUNICIPAL CODE AMENDING THE BAIL FOR PARKING COMPLAINTS
