AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CHULA VISTA AMENDING CHULA VISTA MUNICIPAL CODE SECTION 2.04.150 RELATING TO THE CONSENT CALENDAR FOR CITY COUNCIL MEETINGS

The City Council of the City of Chula Vista hereby ordains as follows:

SECTION I: Section 2.04.150 of the Chula Vista Municipal Code is hereby amended to read as follows:

Sec. 2.04.150 Consent Calendar.

- CELLAIN Items for inclusion on the agenda, which Α. have been reviewed by the city manager and staff, mailed to the council for study and which are made available to the public prior to and at council meetings, shall be grouped together for action/at mayfaya/ate//donaidam/do//da//da//noncontionetsial/and in//xne/naknke//of//ngusekeeping/nceme//oy/the//stefff, action by 79741444444/he council. Staff recommendations on the action to be taken for said items shall be indicated in a concise and summary form. These matters shall be listed under what is to be known as the "consent calendar" in the order of business as indicated in Section 2.04.140. Adoption of the consent calendar may be made by a simple motion approved by the city council; provided, however, that the presiding officer shall first advise the audience that the consent calendar matters will be so adopted, toto, by one action of the council unless any councilmember or any individual or organization interested in one or more consent calendar items has any question or wishes to make a statement relative to such any item. In that event, the presiding officer may defer action on particular matter or matters and place the same on teanlat agenda for consideration in such order as he deems appropriate.

There will be no separate discussion of these items prior to the time the council votes on the motion unless members of the council, staff, or the public request specific items to be discussed and/or removed from the Consent Calendar for separate Members of the public who wish to action. discuss a Consent Calendar item should come forward to the lectern upon the invitation by the Mayor, state their name, address and Consent Calendar item number."

SECTION II: This ordinance shall be in full force and effect thirty (30) days from and after the date of its adoption.
