

ORDINANCE NO. 2119

AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING SECTION 2.48.040 OF THE CHULA VISTA MUNICIPAL CODE PERTAINING TO THE FORMATION OF A COMMUNITY PLANNING COMMITTEE IN TERRITORY PROPOSED FOR ANNEXATION

The City Council of the City of Chula Vista does ordain as follows:

SECTION I: That Section 2.48.040 of the Chula Vista Municipal Code is hereby amended to read as follows:

Sec. 2.48.040 Formation Procedure in Territory Proposed for Annexation

In an area proposed for annexation, the city council shall at the time of the public hearing consider the question of the formation of a community planning committee and may place the issue of annexation and the formation of a community planning committee ~~along with~~ //a//slate//of//candidates//composed//of//electors//of//the//area//to//be//annexed on the ballot ~~as an alternative method of selection to that of appointment by the city council as provided herein.~~


The city council may fill the positions on the community planning committee by:

- A. Appointment.
- B. Placing a slate of candidates composed of electors of the area to be annexed on the ballot.
- C. By adopting a resolution at the conclusion of the public hearing requiring that the seven candidates with the most votes be elected to the community planning committee for initial terms after which subsequent terms shall be filled by appointment.

The council shall designate the method of selection at the public hearing.

SECTION II: This ordinance shall take effect and be in full force on the thirty-first day from and after its adoption.

ORDINANCE NO. 2119

AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING SECTION 2.48.040 OF THE CHULA VISTA MUNICIPAL CODE PERTAINING TO THE FORMATION OF A COMMUNITY PLANNING COMMITTEE IN TERRITORY PROPOSED FOR ANNEXATION

By a unanimous vote on July 16, 1985 (Councilman Scott was absent), the Council placed the ordinance on its second reading and adoption.

At the Municipal and District General Elections on November 5, 1985, the question of annexing the Montgomery area to the City of Chula Vista will be placed on the ballot. If the annexation is approved by the electorate, a Montgomery Community Planning Committee will be established. On the November 5, 1985 ballot, the voters in the Montgomery area will be asked to vote for seven (7) candidates to serve on the Committee. The top seven vote-getters will be elected to this Committee for their initial term but subsequent terms will be filled by appointment by the City Council.
