In addition to those Unclassified positions specifically delineated in Section 500 of the Charter of the City of Chula Vista, there are hereby established the Unclassified positions entitled Deputy City Manager, Assistant to the City Manager, Deputy City Clerk, Assistant Fire Chief, Assistant Director of Planning, City Engineer, #14404/AA/DOY144/AhA15616/Ahd/Ptostam ENAIMATION <u>Director</u> of <u>Management</u> Services, Redevelopment Coordinator, Housing Coordinator, AND Coordinator, and Transit Coordinator, Assistant Director of Community Development, Deputy Director of Public Works/Engineering, Public Information Coordinator, Traffic Engineer, and Public Services Director.

SECTION II: This ordinance shall take effect and be in full force and effect on the thirty-first day from and after its adoption.

AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING SECTION 2.05.010 OF THE CHULA VISTA MUNICIPAL CODE BY PLACING CERTAIN MANAGEMENT LEVEL EMPLOYEE POSITIONS IN THE UNCLASSIFIED SERVICE.

By a unanimous vote on July 16, 1985, (Councilman Scott was absent), the Council placed the ordinance on its second reading and adoption.

Section 2.05.010 of the Chula Vista Municipal Code lists positions in the unclassified service. This section of the Code was last amended in May 1980. This ordinance amends the Code by adding other executive and middle management level positions included Since May 1980.
