Municipal Code be, and the same is hereby repealed.


SECTION II: This ordinance shall take effect and be in

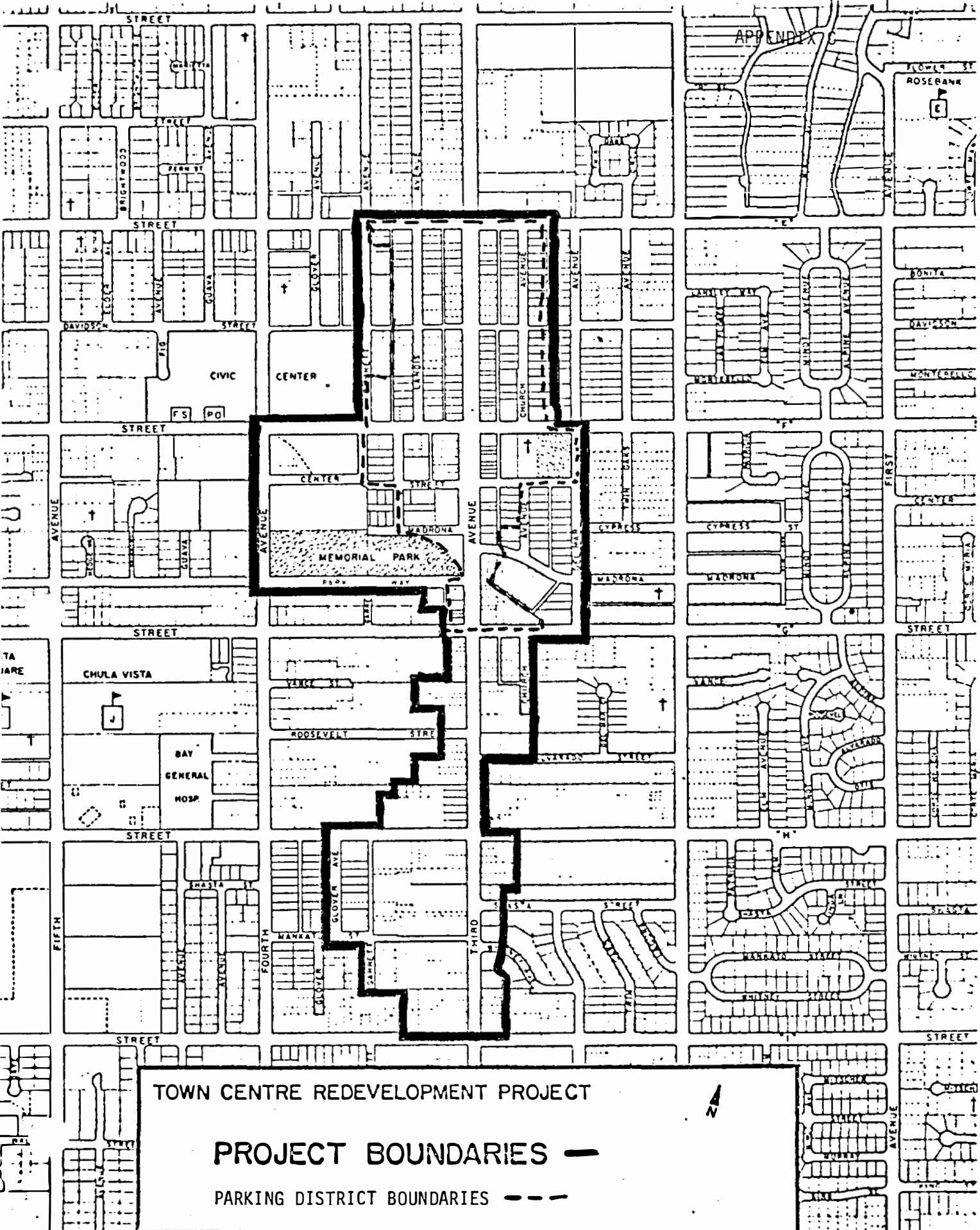
