AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING SECTION 19.04.007 OF THE CHULA VISTA MUNICIPAL CODE RELATING TO THE DEFINITION OF ADULT BOOKSTORE

The City Council of the City of Chula Vista does ordain as follows:

SECTION I: That Section 19.04.007 of the Chula Vista Municipal Code is hereby amended to read as follows:

Sec. 19.04.007 Adult bookstore.

"Adult bookstore" means an establishment which devotes more than fifteen (15) percent of the total floor area utilized for the display of books and periodicals to the display and sale of the following:

- Books, magazines, periodicals, or other printed matter, or photographs, films, motion pictures, video cassettes, slides, tapes, records, or other forms of visual or audio representations which are characterized by an emphasis upon the depiction or description of specified sexual activities or specified anatomical areas; or
- 2. Instruments, devices or paraphernalia which are designed for use in connection with specified sexual activities.

An adult bookstore does not include an establishment that sells books or periodicals as an incidental or accessory part of its principal stock-in-trade and does not devote more than fifteen (15) percent of the total floor area of the establishment to the sale of books and periodicals.

SECTION II: This ordinance shall take effect and be in full force on the thirty-first day from and after its adoption.
