ORDINANCE NO. 2267

AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING CHAPTERS 6.04, 6.08 AND 19.04 OF THE CHULA VISTA MUNICIPAL CODE RELATING TO THE NUMBER OF DOGS AND CATS PERMITTED ON RESIDENTIAL PROPERTIES

WHEREAS, the City Council, in response to a written request from Mrs. Patricia Bodi, directed staff to review the City's animal regulations to determine if it would be appropriate to allow a greater number of dogs on single family lots, and

WHEREAS, the proposal is a Class 5 f exemption from environmental review.

The City Council of the City of Chula Vista does ordain as follows:

SECTION I: That Sections 6.04 .030 and 6.08 .010 of the Chula Vista Municipal Code are hereby amended to read as follows:


Section 6.08.010 Definitions
R .
"Cattery" kept for selling or exchanging of cats;
C. $\quad$ Kennel" means a place whdx kept for the purpose of boarding, breeding, raising, selling or exchanging of dogs;
E. "Pet shop" means an establishment involved in selling or exchanging (but excluding boarding, breeding or raising). any birds, dogs or other pets, all of which for the purpose of this chapter are called pets.
F. Eん "Puppy" means a dog of four months or less in age.

SECTION II: That Section 6.08 .070 of the Chula Vista Municipal Code be, and the same is hereby repealed.







SECTION III: That Section 19.04 .118 of Chapter 19.04 of the Chula Vista Municipal Code is hereby amended to read as follows:

Sec. 19.04.118 Kennel

SECTION IV: That Section 19.04 .179 is hereby added to Chapter 19.04 to read as follows:
$\frac{\text { Sec. 19.04.179 }}{\text { "Pet shop" means an }}$ exchanging (but excluding boarding, breeding or raising) any birds, dogs or other pets, all of which for the purpose of this chapter are called pets.

SECTION V: This ordinance shall take effect and be in full force on the thirty-first day from and after its adoption.
