

ORDINANCE NO. 2353

AN ORDINANCE OF THE CITY OF CHULA VISTA ADDING SECTION 19.58.410 TO THE CHULA VISTA MUNICIPAL CODE TO PROHIBIT FLASHING LIGHTS

WHEREAS, in February 1989, the Zoning Enforcement Division of the City of Chula Vista cited a commercial establishment for its use of flashing lights surrounding a sign, and

WHEREAS, the case was subsequently reviewed by the City Attorney, who felt that the Municipal code would need to be amended in order to be defensible in court in prohibiting flashing lights, and

WHEREAS, an initial study, IS-90-14, of possible adverse environmental impacts of the proposed amendment was conducted and the Environmental Review Coordinator concluded that there would be no significant effects and recommends adoption of the negative declaration, and

WHEREAS, on November 29, 1989, the Planning Commission voted unanimously to recommend that the City Council adopt the amendment in accordance with Resolution PCA-90-1.

The City Council of the City of Chula Vista does hereby ordain as follows:


SECTION I: That Section 19.58.410 be added to the Chula Vista Municipal Code to read as follows:

Sec. 19.58.410 Prohibition of Flashing Lights.

Lights in view of any public street or adjoining properties used to convey the effect of movement are prohibited. Intermittent or variable intensity lights, or flashing lights are prohibited, with the exception of holiday lights during the month of December.


SECTION II: This ordinance shall take effect and be in full force and effect on the thirtieth day from and after its adoption.






