

ORDINANCE NO. 2450

AN ORDINANCE OF THE CITY OF CHULA VISTA AMENDING SECTION 2.05.010 OF THE CHULA VISTA MUNICIPAL CODE TO ESTABLISH THE REVENUE MANAGER POSITION AND RETITLE THE BUDGET OFFICER POSITION IN THE UNCLASSIFIED SERVICE OF THE CITY OF CHULA VISTA

WHEREAS, Charter Sections 500(a) and 701(a)(8) authorize the City Council to create a new Management level positions in the Unclassified Service by an ordinance adopted by a four-fifths vote; and,

WHEREAS, it is desirable to create a new Management level position of Revenue Manager; and,

WHEREAS, on January 22, 1991, by Resolution No. 16021, Council approved placement of the Budget Officer position in the Executive Serviced and renamed the position (already in the Unclassified Service) but the ordinance placing the position in the Unclassified Service was inadvertently not amended to reflect the title change.

NOW, THEREFORE, the City Council of the City of Chula Vista does ordain as follows:

Section I. Section 2.05.010 of the Chula Vista Municipal Code is amended to read:

Sec. 2.05.010 Unclassified positions established.


In addition to those unclassified positions specifically delineated in Section 500 of the Charter of the City, there are established the unclassified positions entitled deputy city manager, assistant to the city manager, deputy city clerk, assistant fire chief, assistant director of planning, assistant director of finance, assistant director of personnel, city engineer, director of management services, redevelopment coordinator, housing coordinator, transit coordinator, assistant director of community development, deputy director of public works/city engineer, public information coordinator, traffic engineer, deputy director of public works/operations, budget manager, revenue manager, assistant director of management services, and assistant library director.

SECTION II: This ordinance shall take effect and be in force on the thirtieth day from and after its adoption.
