

ORDINANCE NO. 2615

ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CHULA VISTA AMENDING SCHEDULE X OF SECTION 10.48.050 OF THE CHULA VISTA MUNICIPAL CODE TO ESTABLISH SPEED LIMITS ON DEL REY BOULEVARD AND RANCHO DEL REY PARKWAY

WHEREAS, the City Engineer has determined the need to establish speed limits on Del Rey Boulevard and Rancho del Rey Parkway in the Rancho del Rey development; and,

WHEREAS, a traffic and engineering study, as required by State Law, was conducted by staff who concluded that this area will operate safer and more efficiently provide for the movement of traffic with the posted speed limit of 40 M.P.H. on Del Rey Boulevard and a posted speed limit of 35 M.P.H. on Rancho del Rey Parkway; and,

WHEREAS, the Safety Commission at its meeting of October 13, 1994 voted 5-0-2 to recommend to the City Council that the speed limited be adopted and be added to the Municipal Code.


NOW, THEREFORE, the City Council of the City of Chula Vista does ordain as follows:

SECTION I: That Schedule X of Section 10.48.050 of the Chula Vista Municipal Code, Decreasing State Law Maximum Speed Limits in Certain Areas, is hereby amended to include the following changes:


SECTION II: This ordinance shall take effect and be in full force on the thirtieth day from and after its adoption.


