

ORDINANCE NO. 267
AN ORDINANCE OF THE CITY OF
CHULA VISTA, CALIFORNIA,
AMENDING ORDINANCE NO. 163 OF
SAID CITY ENTITLED "AN ORDINANCE OF THE CITY OF CHULA VISTA, CALIFORNIA, PROVIDING FOR THE CREATION IN SAID CITY OF FIVE ZONES, CONSISTING OF VARIOUS DISTRICTS, AND PRESCRIBING THE CLASSES OF BUILDINGS, STRUCTURES AND IMPROVEMENTS IN SAID SEVERAL ZONES AND THE USES THEREOF; DEFINING THE TERMS USED, HEREIN PRESCRIBING THE PENALTY FOR THE VIOLATION OF THE PROVISIONS HEREOF AND REPEALING ANY ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH," as amended, BY REMOVING CERTAIN PROPERTIES FROM ZONE "A" INTO ZONE "B".

THE CITY COUNCIL OF THE CITY OF CHULA VISTA, CALIFORNIA, DOES ORDAIN AS FOLLOWS:

SECTION 1. That Section 2 of Ordinance No. 163 of the City of Chula Vista, California, as amended by Section 2 of Ordinance No. 220, be and the same is hereby amended as follows, to-wit:

That the following described property in the said City be, and the same is hereby removed from Zone "A" and into Zone "B":

Block A, excepting Lots 1, 2, 12 and 13;
Block B, excepting Lots 1, 2, 12 and 13;
Block C, excepting Lots 1, 2, 12 and 13;
Block D, excepting Lots 1, 2, 12 and 13;
all being in La Playa Vista Tract, and which Tract is bounded by National Avenue on the West, G Street on the North, Smith Avenue on the East, and H Street on the South;

The Easterly 125 feet of Block A of Central Addition, which area is bounded on the South by F Street, on the East by Fourth Avenue, and by Davidson Street on the North.

SECTION 2. All Ordinances and parts of Ordinances in conflict herewith are hereby repealed.

SECTION 3. This Ordinance shall take effect and be in force on the 31st day after its final passage and approval.

ORDINANCE NO. 267

AN ORDINANCE OF THE CITY OF CHULA VISTA, CALIFORNIA, AMENDING ORDINANCE NO. 163 OF SAID CITY ENTITLED "AN ORDINANCE OF THE CITY OF CHULA VISTA, CALIFORNIA, PROVIDING FOR THE CREATION IN SAID CITY OF FIVE ZONES, CONSISTING OF VARIOUS DISTRICTS, AND PRESCRIBING THE CLASSES OF BUILDINGS, STRUCTURES AND IMPROVEMENTS IN SAID SEVERAL ZONES AND THE USES THEREOF; DEFINING THE TERMS USED HEREIN, PRESCRIBING THE PENALTY FOR THE VIOLATION OF THE PROVISIONS HEREOF AND REPEALING ANY ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH", as amended, BY REMOVING CERTAIN PROPERTIES FROM ZONE "A" INTO ZONE "B".

THE CITY COUNCIL OF THE CITY OF CHULA VISTA, CALIFORNIA, DOES ORDAIN AS FOLLOWS:

SECTION 1. That Section 2 of Ordinance No. 163 of the City of Chula Vista, California, as amended by Section 2 of Ordinance No. 220, be and the same is hereby amended as follows, to-wit:

That the following described property in the said City be, and the same is hereby removed from Zone "A" and into Zone "B":

Block A, excepting Lots 1, 2, 12 and 13; Block B, excepting Lots 1, 2, 12 and 13; Block C, excepting Lots 1, 2, 12 and 13; Block D, excepting Lots 1, ~~12~~ 2, 12 and 13; all being in La Playa Vista Tract, and which Tract is bounded by National Avenue on the West, G Street on the North, Smith Avenue on the East, and H Street on the South;

The Easterly 125 feet of Block A of Central Addition, which area is bounded on the South by F Street, on the East by Fourth Avenue, and by Davidson Street on the North.

SECTION 2. All Ordinances and parts of Ordinances in conflict herewith are hereby repealed.

SECTION 3. This Ordinance shall take effect and be in force on the 31st day after its final passage and approval.
