

ORDINANCE NO. 2861

ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CHULA VISTA ESTABLISHING A 25-MPH SPEED LIMIT ON SILVERADO DRIVE, BETWEEN CLUBHOUSE DRIVE AND SOUTH GREENSVIEW DRIVE, AND ADDING THIS ROADWAY SEGMENT TO SCHEDULE X OF A REGISTER MAINTAINED BY THE OFFICE OF THE CITY ENGINEER

WHEREAS, based on the provisions of Division 11-Chapter 7-Article 1 and Division 17-Chapter 3-Article 1 of the California Vehicle Code, and pursuant to authority under Chula Vista Municipal Code Section 10.48.020, the City Engineer has determined that, in the interest of minimizing traffic hazards and for the promotion of public safety, the speed limit on Silverado Drive between Clubhouse Drive and South Greensview Drive be established at 25 MPH.

NOW, THEREFORE, the City Council of the City of Chula Vista does ordain as follows:

SECTION I: That Schedule X of a Register of Schedules maintained by the City Engineer as provided in Section 10.48.020 of the Chula Vista Municipal Code, Established Speed Limits in Certain Zones – Designated, is hereby amended to include the following changes:


SECTION II: This ordinance shall take effect and be in full force on the thirtieth day from and after its adoption.
