## ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CHULA VISTA ADOPTING THE CALIFORNIA FIRE CODE, 2001 EDITION

### THE CITY COUNCIL OF THE CITY OF CHULA VISTA DOES ORDAIN AS FOLLOWS:

SECTION I. That Chapter 15.36 of the Chula Vista Municipal Code is hereby amended to read as follows:

#### 15.36.010 California Fire Code, 2001 Edition.

There is hereby adopted by reference that certain document known and designated as the California Fire Code, 2001 Edition and all Appendices, as compiled and published by the International Fire Code Institute in cooperation with the International Conference of Building Officials and the Western Fire Chiefs Association, three (3) copies of which are on file in the office of the City Clerk. Subject to such amendments as are herein contained, said document is hereby adopted prescribing regulations governing conditions hazardous to life and property from fire or explosion, and each and all such regulations, provisions, penalties, conditions and terms of said California Fire Code are hereby referred to, adopted and made a part hereof as though fully set forth herein, excepting such portions as are hereinafter deleted, modified or amended as set forth in this Chapter.

#### SECTION II. ENVIRONMENTAL IMPACT.

The Environmental Review Coordinator has reviewed the proposed activity for compliance with the California Environmental Quality Act (CEQA) and has determined that the activity is not a "Project" as defined under Section 15378 of the State CEQA Guidelines; therefore, pursuant to Section 15060(c)(3) of the State CEQA Guidelines the activity is not subject to CEQA. Thus, no environmental review is necessary.

#### SECTION III. EFFECTIVE DATE.

This ordinance will take effect and be in force on November 1, 2002.
