AN ORDINANCE OF THE CITY OF CHULA VISTA, CALIFORNIA, APPOINTING THE CITY ENGINEER OF THE CITY OF CHULA VISTA TO PERFORM THE DUTIES OF THE STREET SUPERINTENDENT IN PROCEEDINGS UNDER THE IMPROVEMENT ACT OF 1911 AND REPEALING ORDINANCE NO. 535.

WHEREAS, this City Council proposes to initiate proceedings under the Improvement Act of 1911 for the construction of certain street improvements in the City of Chula Vista; and

WHEREAS, there is not at the present time a Street Superintendent or Superintendent of Streets in the City of Chula Vista, and this City Council deems it desirable that the City Engineer of said City perform the duties imposed upon the Street Superintendent by said Improvement Act of 1911;

NOW, THEREFORE, the City Council of the City of Chula Vista, California, DOES HEREBY ORDAIN as follows:

Section 1. That pursuant to the provisions of Section 5012 of the Streets and Highways Code, the City Engineer of the City of Chula Vista be and he hereby is appointed to perform the duties imposed upon the Street Superintendent by said improvement Act of 1911, and all of the provisions of said improvement Act of 1911 applicable to the Street Superintendent shall apply to said City Engineer, and the City Council hereby assigns aaid duties to the City Engineer as additional functions and duties of the office of City Engineer.

Section 2. That Ordinance No. 535 of the Ordianances of the City of Chula Vista, California, be and the same is hereby repealed.

Section 3. This ordinance shall take effect upon its adoption.
