ORDINANCE NO. 776

AN ORDINANCE AMENDING SECTIONS 6.1 AND 6.28 AND REPEALING SECTIONS 6.3 THROUGH 6.22, 6.24 THROUGH 6.27 AND 6.29 THROUGH 6.56 OF CHAPTER 6 OF THE CODE OF THE CITY OF CHULA VISTA, CALIFORNIA, ALL OF WHICH AFORESAID SECTIONS CONCERN THE ENFORCEMENT OF PART 2, DIVISION 13, OF THE CALIFORNIA HEALTH AND SAFETY CODE AND THE CALIFORNIA ADMINISTRATIVE CODE, TITLE 8, CHAPTER 9, ARTICLES 2, 3, 4 AND 5, PERTAINING TO MOBILEHOMES AND MOBILEHOME PARKS.

THE CITY COUNCIL OF THE CITY OF CHULA VISTA, CALIFORNIA DOES ORDER AS FOLLOWS:

SECTION I. That Sections 6.1 and 6.28 of Chapter 6 of the code of the City of Chula Vista, California are hereby amended to read as follows:

SECTION 6.1 Enforcement of State Mobilehome Regulations.

Pursuant to the provisions of Section 18010, Part 2, Division 13, of the California Health and Safety Code, the Division of Housing of the Building Inspection Division of the Department of Public Works is hereby charged with the enforcement of Part 2, Division 13 of the California Health and Safety Code and the California Administrative Code, Title 8, Chapter 9, Article 2, 3, 4 and 5, pertaining to mobilehomes and mobilehome parks.

SECTION 6.28 Tent Camps Prohibited.

No tent camps shall be erected or maintained within the City of Chula Vista.

SECTION III. That Sections 6.3 through Section 6.22, Sections 6.24 through 6.27 and Sections 6.29 through 6.56 of the code of the City of Chula Vista are hereby repealed.

SECTION IIII. Repeal of Sections 6.3 through 6.22, Sections 6.24 through 6.27 and Sections 6.29 through 6.56 of the code of the City of Chula Vista shall not affect any punishment or penalty incurred before the repeal of said Sections 6.3 through 6.22, Sections 6.24 through 6.27 and sections 6.29 through 6.56 of the city code, or any suit, prosecution or proceedings pending at the time of said repeal, for any offense committed under Sections 6.3 through 6.22, Sections 6.24 through 6.27 and Sections 6.29 through 6.56 of the city code.

SECTION IV. This Ordinance shall be effective and be in force thirty (30) days after the final passage thereof, and shall within fifteen (15) days after its final passage, be published once in the Chula Vista Star-News, a newspaper of general circulation, printed and published in the City of Chula Vista, California.
