AN ORDINANCE AMENDING SECTION 4.05 OF ORDINANCE NO. 398 OF THE CITY OF CHULA VISTA.

THE CITY COUNCIL OF THE CITY OF CHULA VISTA DOES ORDAIN AS FOLLOWS:

Section 1: Section 4.05 of Ordinance No. 398 is hereby amended to read as follows:

SECTION 4.05: ZONING MAPS. The zones set forth in Sections 4.00, 4.10 and 4.11 of this Ordinance, and the boundaries of all of said zones, are shown upon those maps attached hereto, being designated as the "Zoning Map", "Zoning Map II", and each Zoning Map numbered consecutive—ly thereafter, to and including Zoning Map No. 68 except therefrom Zoning Map No. XXIX, and said maps and all other notations, references and other information shown thereon shall be as much a part of this ordinance as if the matters and information set forth on said maps were all fully described herein.


