RESOLUTION NO. 247148

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE CITY OF CHULA VISTA, COUNTY OF SAN DIEGO, STATE OF CALIFORNIA, DETERMINING THAT THE PUBLIC INTEREST AND PUBLIC NECESSITY OF THE CITY OF CHULA VISTA DEMAND THE ACQUISITION AND CONSTRUCTION BY SAID CITY OF A CERTAIN MUNICIPAL IMPROVEMENT, TO-WIT: A PUBLIC PARK, INCLUDING THE ACQUISITION OF CERTAIN LAND AND THE IMPROVEMENT OF THE SAME FOR PARK PURPOSES BY THE ACQUISITION, CONSTRUCTION AND COMPLETION THEREON OF WALKS, DRIVES, ATHLETIC GROUNDS, INCLUDING TENNIS COURTS, BASKET BALL COURTS, AND BASE BALL GROUNDS, AND OTHER STRUCTURES, BUILDINGS OR WORKS NECESSARY FOR THE COMPLETION OF SUCH MUNICIPAL IMPROVEMENT; AND DETERMINING THAT THE COST THEREOF IS AND WILL BE TOO GREAT TO BE PAID OUT OF THE ORDINARY ANNUAL INCOME AND REVENUE OF SAID CITY OF CHULA VISTA.

The Board of Trustees of the City of Chula Vista do resolve and determine that the public interest and public necessity of the City of Chula Vista demand the acquisition and construction by said City of a certain municipal improvement, to-wit: A public park, including the acquisition of certain land described as the East Half (1/2) of Ten-Acre, Fifteen and Sixteen (15 and 16), in Quarter Section One Hundred and Fifty (150), of Chula Vista, in the City of Chula Vista, County of San Diego, State of California, according to map thereof, No. 505, filed in the office of the County Recorder of said San Diego County, March 13, 1888,

and the improvement of the same for park purposes by the acquisition, construction and completion thereon of walks, drives, athletic grounds, including tennis courts, basket ball courts, and base ball grounds, and other structures, buildings or works necessary for the completion of such municipal improvement; that said municipal improvement is necessary and convenient to carry out the objects, purposes and powers of said municipality; that the estimated cost of such municipal improvement is the sum of Seven Thousand, Five Hundred dollars (\$7,500.00); and that the cost thereof is and will be too great to be paid out of the ordinary annual income and revenue of said City of Chula Vista.
