## RESOLUTION NO. 17220

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHULA VISTA AFFIRMING THE TRIAL TRAFFIC REGULATIONS - SCHEDULE III - PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS

WHEREAS, on April 21, 1992, a Trial Traffic Regulation establishing a parking prohibition in the Point Robinhood Subdivision was implemented pursuant to the provisions of Section 10.12.030 of the Chula Vista Municipal Code; and,

WHEREAS, signs indicating this prohibition were installed on September 25, 1992; and,

WHEREAS, the Safety Commission, at their meeting of July 8, 1993, voted 6-0-1 (Koester absent) to recommend that the City Council affirm this Trial Traffic Regulation and approve a resolution making this prohibition permanent.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Chula Vista does hereby affirm the trial traffic regulations - Schedule III - Parking Prohibited at all Times on Certain Steets pursuant to the provisions of Section 10.12.030 of the Chula Vista Municipal Code, in the interest of minimizing traffic hazards and congestion and for the promotion of public safety, on the following streets:
