RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
CHULA VISTA APPROVING A MODIFIED AGREEMENT
WITH SAN DIEGO ASSOCIATION OF GOVERNMENTS FOR
THE PROPOSITION 64 PUBLIC HEALTH AND SAFETY
GRANT PROGRAM

WHEREAS, the City of Chula Vista desires to participate in the Proposition 64 Public Health and Safety Grant Program funded through the California State and Local Government Law Enforcement Account and administered by the Board of State and Community Corrections (“BSCC”); and

WHEREAS, on April 19, 2023, the Police Department received notice from BSCC of a \$2,708,250 award of Proposition 64 Public Health and Safety Cohort 3 grant to address local impacts due to the legalization of adult-use recreational cannabis in California; and

WHEREAS, on July 25, 2023, the City Council approved a form of agreement with San Diego Association of Governments (“SANDAG”) to provide program evaluation services for the Proposition 64 Public Health and Safety Grant Program; and

WHEREAS, the City and SANDAG now desire to make additional modifications to the unexecuted form of agreement.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Chula Vista, that it approves the modified Agreement to provide Program Evaluation Services for the Proposition 64 Public Health and Safety Grant Program between the City and San Diego Association of Governments, in the form presented, with such minor modifications as may be required or approved by the City Attorney, a copy of which shall be kept on file in the Office of the City Clerk, and authorizes and directs the Mayor to execute same.




