RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHULA VISTA ACCEPTING BID AND AUTHORIZING THE PURCHASE OF UP TO TWENTY-FIVE FORD INTERCEPTOR UTILITY HYBRID VEHICLES FROM SEDANO FORD

WHEREAS, on November 6, 2023, the City of Chula Vista issued Request for Bid (RFB) # B14-2024 for ten to twenty-five (10-25) units of 2025 Ford Interceptor Utility Hybrid vehicles for the Police Department; and

WHEREAS, Sedano Ford was selected because they were the lowest bidder at \$58,171.89 per vehicle; and

WHEREAS, the price offered by Sedano Ford appears competitive for current market conditions and with past pricing; and

WHEREAS, the Police Department is requesting authorization to purchase twenty (20) vehicles at this time and an additional five vehicles at the bid amount during a later time due to unanticipated vehicle replacements; and

WHEREAS, the total cost for twenty (20) Ford Interceptor Utility Hybrid vehicles is \$1,163,438; the additional five vehicles will cost \$290,859.45.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Chula Vista, that it accepts the bid from Sedano Ford, as presented, and authorizes the purchase of up to twenty-five (25) Ford Interceptor Utility Hybrid vehicles from Sedano Ford, at a cost of \$58,171.89 per vehicle, for use by the Chula Vista Police Department.
