RESOLUTION OF INTENTION NO. 275 FLOWER STREET \*-CEDAR AVENUE- FIRST AVENUE -

RESOLVED, by the City Council of the City of Chula Vista, in the County of San Diego, State of California, that the public interest and convenience requires the following public work and improvement, to be done in the said City, and therefore the City Council of said City, hereby declares its intention to order the following described public work and improvements. in said City, to-wit:

She construction of cement concrete sidewalks and cement concrete curbing on the northerly side of Flower Street between a line two feet westerly from the easterly line of National Avenue and a line 90 feet easterly from the easterly line of National Avenue.

Also the construction of cement concrete sidewalk and cement concrete westerly curbing on the northerly side of Flower Street between the/line of Cedar A Avenue and a line 604.43 feet westerly from the westerly line of Cedar Avenue; also cement concrete sidewalk and cement concrete curbing in the return at the northwest corner of Flower Street and Cedar Avenue; also cement concrete sidewalk and cement curbing in the return at the northeast corner of Flower Street and Cedar Avenue.

Also the construction of cement concrete midewalk and cement concrete curbing on the northerly side of Flower Street between the easterly line of Cedar Avenue and a line 151.02 feet easterly from the easterly line of Gedar Avenue.

Also the construction of Cement Constructs sidewalk and cement concrete curbing on the northerly side of Flower Street between the westerly line of First Avenue and a line 120 feet westerly from the westerly line of First Avenue; also the construction of cement concrete sidewalk and cement concrete curbing in the return at the northwest corner of Flower Street and First Avenue.

Also the construction of cement concrete sidewalk and cement concrete curbing on the southerly dide of Flower Street between a line 320 feet westerly from the westerly line of First Avenue and a line 1062. 45 feet westerly from the westerly line of First Avenue.

Also the construction of cement concrete sidewalk and cement convrete curbing on the westerly side of First Avenue between the northerly line of Flower Street and a line 100 feet northerly kinesefallsmeralized and a line of Flower Street.

Also the construction of cement concrete sidewalk and cement concrete curbing on the easterly side and on the westerly side of Cedar Avenue between the northerly line of Flower Street and a line 102.01 feet northerly from the northerly line of Flower Street, excepting therefrom any of said work already done to the official grade or the the satisfaction of the Street Supcrintendent on any of said streets or avenues.

All of said work hereinbefore generally described shall be constructed in the manner, at the locations, within the limits, of the materials, and of the dimensions, as shown upon and according to the plans, drawings, typical cross-sections, profiles, and specifications therefor contained/in document 86 on file in the office of the City Clerk of said City, and copies of which are on file in the office of the City Engineer of said City, heretofore approved and adopted by the City Council of said City as the plans, drawings, typical cross-sections, profiles, and specifications to be followed in making said improvement; and by this reference thereto all said plans, drawings, typical cross-sections, profiles, and specifications are incorporated herein and made a part hereof.

ed in the manner, at the locations, within the limits, of the materials, and of the dimensions as shown upon and according to the prans, drawings typical cross-sections, profiles and specifications therefor contained in document No. 86 on file in the office of the City Clerk of said City, and copies of which are on file in the office of the City Engineer of said City, heretofore approved and adopted by the City Council of said City as the plans, drawings, typical cross-sections, profiles and specifications to be followed in making said improvement; and by this reference thereto all said plans, drawings, typical cross-sections, profiles and specifications destines and specifications.

The said City Council hereby determines and declares that serial bonds shall be issued to represent each assessment of twenty-five dollars or more remaining unpaid after the full expiration of twenty days from the date of the warrant, to represent the expense of said work and improvement, said, serial bonds shall extend over a period of nine years from the second day Of January next succeeding the fifteenth day of next November following their date and an even annual proportion of the principal sum thereof shall be pays able by coupon on the second day of January every year after the fifteenth day of the next November following their date until the whole is paid.

Said bonds shall bear interest at the rate of seven per cent per annum, interest payable semi-annually by coupon on all sums unpaid intil the whole of said principal and interest are paid. Said bonds shall be issued and the principal and interest thereof shall be paid under and in pursuance of the "Improvement Act of 1911" and amendments thereto.

That the contemplated work and improvement hereinbefore mentioned fublic is in the opinion of said City Council of more than local and ordinary, bene fit and the expenses of such work and improvement are made chargeable upon the district hereinafter described, and said City Council does hereby declare said district to be the district benefited by said work and improvement, and to be assessed to pay the costs and expenses thereof.

Said district is described as follows, to-wit; All that real property in the said City of Chula Vista included within the exterior boundary lines of said district, as shown upon that partain plat No. <u>866</u> indicating the exterior boundary lines of such district, which plat approved by the said City Council, is on file in the office of the City Engineer of said City; excepting therefrom all public streets, roads, alleys, avenues and highways. Reference is hereby made to said plat for a particular description of such district.

NOTICE IS HEREBY GIVEN, that on the <u>6th</u> day of <u>Murch</u>. <u>1928</u> at <u>7.30</u> o'clock P. M', in the Council Chamber of the City Council in the City Hall of said City, in the City of Chula Vista, State of California, any and all persons having any objections to the proposed work and improvement may appear before said City Council and show cause why said proposed improvement should not be carried out in accordance with this resolution.

That the City Clark of said City be , and he is hereby directed to eause this resolution of intention to be published twice in the Chula Vista Star, a weekly newspaper, published and circulated generally in said City and hereby designated for that purpose by the City Council , there being no daily newspaper published in said City of Chula Vista.

That the Street Suprantendent of said City shall after the adoption of this resolution of intention, cause to be conspicuously posted along the line of said contemplated work and improvement, at not more than three hundred feet in distance apart, but not less than three in all, notices of the passage of this resolution of intention, and when the work to be done is only then an entire crossing or intersection, or any part thereof, he shall cause such notices to the conspicuously posted in front of each quarter block or irregular block liable to be assessed, and when work is chargeable upon a district, he shall cause such notices to be conspicuously posted upon all open streets within such district, at not more than three hundred feet in distance apart on each street so posted, all in the time, form and \* manner required by law; and thereupon said Supfintendent of Streets shall cause to be filed in the office of the City Clerk of said City, an affidavit showing the posting of said notices of improvement.

The said City Council does not deem it advisable that the City Clerk of sadd City mail copies of the Notice of improvement to owners or reputed owners, and he is not required to mail same.

That the grade on Flower Street in said City from First Avenue to Na-b tional Avenue in said City be and the same is hereby established and confirmed as **follows**; At the intersection with said First Avenue the grade shall be 62. O5 feet at the northwest corner and 62.42 feet at the southwest corner; At the intersection with said National Avenue the grade east shall be 49.97 feet at the northeast corner and 49.75 feet at the southwest corner; that the grade on Cedar Avenue in said City from "D" Street to Flower Street be and the same is hereby established and confirmed as follows

At the intersection with "D" Street in said City the grade shall be 55.65 feet at the southwest corner and 56.15 feet at the southeast corner;

At the intersection with Flower Street in said City the grade shall be 59.08 feet at the northeast corner and 59.59 feet at the northwest corner. and the same and all thereof is hereby fixed, established and declared to be the official grade of said Flower Street and Cedar Avenue in said City, at all of the points, distances, and places above described and the official grade of said First Avenue in said City has heretofore been duly established and confirmed and all of the foregoing described grades are the grades to which any and all of the aforesaid public work and improvement shall be done and reference is hereby made to the plana make drawings, typical cross-sections profiles and specifications for said public work and improvement and Document No. Section for the description of the grades at which the afgresaid public work and improvement shall be done.

All of the herein proposed work shall be done in pursuance of an Act of the Leglislature of the State of California, designated as the "Improvement Act of 1911," approved April, 7th. 1911, and amendments thereto.
