

RESOLUTION NO. 249  
AND AWARD OF CONTRACT,

RESOLVED by the City Council of the City of Chula Vista, California:

That Notice to Bidders for sealed proposals, addressed to said City

Council, For the Improvement of a portion of Third Avenue by the pav-

ing thereof, commencing Ten feet South of the center line of K Street

in said City of Chula Vista and extending Southerly to the intersection of said South line of L Street

with in said City of Chula Vista a distance of approximately

one hundred and fifty feet miles, with a Warrenite Bitulithic Pavement twenty feet

in width, according to the plans and specifications thereof on file in

the office of the City Clerk of said City, having been duly given, re-

quested and published for the requisite length of time and the affidavit

of publication thereof having been duly filed in the office of the said

City Clerk; and the time and place that said sealed proposals would be

publicly opened and read, so given in said notice, being at 11 o'clock

A. M. June 11th, 1928, at the Council Rooms of said City Council, in the

City Hall in the City of Chula Vista, County of San Diego, State of Cal-

ifornia. All of said sealed proposals were publicly opened and read, <sup>and declared</sup> at said

time and place and there were four of said sealed proposals in all consist-

ing of one by George R. Daley for all Warrenite-Bitulithic Pavement com-

plete in place including all incidental work, per. sq. ft. 16.2 cents.

For preparation of Subgrade, including all incidental work, per lin. ft.

\$1.50, Total for all thereof \$6472.38.

One by R E <sup>Construction Company</sup> Hazzard for said pavement above described per. sq. ft.

16½ cents, For Subgrade above described \$1.20, Total for all thereof being

\$6149.74.

One by Warren Construction Company for said pavement above described per.

sq. ft. 16½ cents, For Subgrade above described \$1.00 per. lin. ft.

Total for all thereof \$5879.74.

One by <sup>The</sup> Griffith Construction Company for said pavement above described

per. sq. ft. 15½ cents, For Subgrade above described 85 cents per. lin.

ft. Total for all thereof \$5402.71 .

Said sealed proposals were then and there duly referred to the City

Engineer of said City for checking : and said City Engineer having

checked the same and made his written report thereon that said <sup>The</sup> Griffith Construction Company submitted the lowest bid therefor and recommended that the contract therefor be awarded to said Company.

It is hereby determined that said <sup>The</sup> Griffith Construction Company's said sealed proposal is the lowest and best bid for said improvement and is in due form and in compliance with law and made by a responsible bidder and the same is hereby accepted and the contract therefor awarded to said <sup>The</sup> Griffith Construction Company on the terms of its said proposal; and the City Council of said City will enter into a contract on behalf of said City with said <sup>The</sup> Griffith Construction Company therefor, upon the furnishing by said Company of the bonds stated and described in said Notice to Bidders, and as required by law; and said <sup>The</sup> Griffith Construction Company is hereby notified of the acceptance of its said sealed proposal and that the contract therefor is prepared and ready for said <sup>The</sup> Griffith Construction Company's signature thereto.

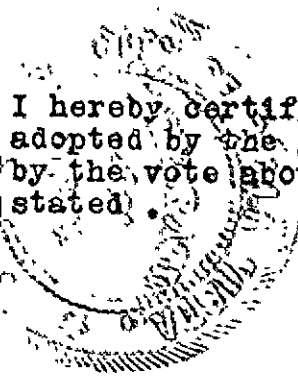
