

The Board of Trustees of the City of Chula Vista do resolve as follows:

That the City Clerk be and he is hereby directed to publish by two insertions in The Chula Vista Review, a weekly newspaper of general circulation published in the said City of Chula Vista, a notice inviting proposals to purchase Street Improvement Bonds in the following form:

**NOTICE OF SALE OF STREET IMPROVEMENT BONDS OF THE CITY OF CHULA VISTA, CALIFORNIA.**

Sealed proposals will be received by the City Clerk of the City of Chula Vista, California, until 7:30 o'clock p.m. of Tuesday, December 9th, 1913, to purchase Street Improvement Bonds of said City of Chula Vista in the amount of Forty Thousand (\$40,000.00) Dollars. Said bonds are twenty year serials and are forty in number, each in the denomination of One Thousand (\$1,000.00) Dollars, and the principal and interest thereof shall be payable in lawful money of the United States.

They shall be dated October 1st, 1913, and bear interest at the rate of six per cent per annum, payable semi-annually, on the first day of April and on the first day of October of each year, at the office of the City Treasurer of the City of Chula Vista. Said forty ~~series~~ bonds shall be payable in the manner following: One twentieth part of the ~~whole~~ amount of such indebtedness shall be paid on October 1, 1914, and one twentieth part of the whole amount of such indebtedness each and every year thereafter.

Said bonds are issued under the authority of the act of the Legislature of the State of California entitled "An Act Authorizing the incurring of indebtedness by Cities, Towns and Municipal Corporations for Municipal Improvements and Regulating the Acquisition, ~~and~~ <sup>and also, parts thereof</sup> Construction or Completion Thereof," which became a law February 25, 1901, and in accordance with the provisions of law and the ordinances of said City.

No proposals for said bonds will be entertained at less than their face value, together with the accrued interest to the date of their delivery, and all bids or proposals submitted will be construed by the Board of Trustees of said City to mean par and accrued interest to the date of delivery of said bonds, in addition to the premium offered, whether the bids or proposals set forth the same explicitly or not.

The said bonds will be ready for delivery on or about the 22nd day of December, 1913, and will be delivered at the City Treasurer's Office in the City of Chula Vista, California, or at any designated place, upon the payment by the purchase of all expenses incurred by the delivery of the bonds and transfer of the money necessary to make delivery and payment equivalent to a transaction at the office of the City Treasurer in the said City of

Chula Vista. All bids or proposals providing for delivery at any place other than the City of Chula Vista, California, will be construed by the Board of Trustees to mean the price bid in addition to the expenses of delivery whether the bid or proposal sets forth the same explicitly or not. With each proposal or bid must be submitted a certified check drawn upon some bank in the State of California, payable to the order of the City Treasurer of the City of Chula Vista, in the sum of Four Hundred (\$400.00) Dollars as a guarantee that the bidder will purchase and pay for said bonds in accordance with his proposal in the event the bid is accepted. The Board of Trustees of said City reserves the right to reject any and all bids or proposals.
