

RESOLUTION NO. 399
OF THE CITY COUNCIL OF THE CITY OF CHULA VISTA, CALIFORNIA,
CHANGING AND MODIFYING RESOLUTION NO. 397, AND INSTRUCTING
ALLEN & ROWE, AS ENGINEERS FOR SAID CITY TO CHANGE AND MODIFY
CERTAIN PROPOSED PLANS AND SPECIFICATIONS FOR PAVING PROJECT,
P. W. A. DOCKET 8025.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHULA VISTA,
CALIFORNIA,

That Resolution No. 397 of the City Council of the City of Chula
Vista, California, passed and adopted the 4th day of March, 1935 be and
the same is hereby changed and modified to read as follows, to-wit:

That that part of Paragraph 3 thereof reading as follows, to-wit:

- "(1) Full Penetration Bitumuls of (a) a thickness of Two (2) inches, of (b) a thickness of One and One-half (1½) inches, and of (c) a thickness of One (1) inch;
- "(2) Full Penetration Emulsified Asphalt in content and quality identical with Bitumuls of (a) a thickness of Two (2) inches, of (b) a thickness of One and One-half (1½) inches, and of (c) a thickness of One (1) inch;"

be changed and modified to read as follows:

- "(1) Full Penetration Bitumuls of (a) a thickness of Two (2) inches, of (b) a thickness of One and One-half (1½) inches, and of (c) a thickness of One (1) inch;
- "(2) Full Penetration Emulsified Asphalt in content and quality as set forth in Section 71 of the Standard Specifications of the State of California Department of Public Works, Division of Highways (January, 1935) of (a) a thickness of Two (2) inches, of (b) a thickness of One and One-half (1½) inches, and of (c) a thickness of One (1) inch;"

That the Engineers, Allen & Rowe, be and they are hereby instruct-
ed to make their proposed Plans and Specifications for P. W. A.
Project 8025 comply herewith;

That the City Clerk be and he is hereby instructed to transmit
a copy of this Resolution to said Engineers.
