

RESOLUTION NO. 407
OF THE CITY COUNCIL OF THE CITY OF CHULA VISTA, CALIFORNIA,
RESPECTING, ASCERTAINING AND ESTABLISHING RATES OF WAGES
FOR AUTHORIZED PUBLIC WORKS PAVING PROJECT IN SAID CITY,
AND RESCINDING RESOLUTION NO. 389.

WHEREAS, the City of Chula Vista, California has heretofore entered into a Loan and Grant Agreement between said City and the United States of America, (said Loan and Grant Agreement being known and described as P.W.A. Docket No. 8025, a copy of which Loan and Grant Agreement is on file in the office of the City Clerk of the City of Chula Vista, California, File No. 416), for the paving of certain streets in said City; and

WHEREAS, the necessary general bonds of said City have been issued for the carrying on of said public work; and

WHEREAS, said public works project will be undertaken in the near future; and

WHEREAS, a number of different crafts or types of laborers, workmen and/or mechanics will be employed therein; and

WHEREAS, Act 6429 of the General Laws of the State of California, entitled: "An act to provide for the payment of not less than the general prevailing wages on public works, etcetera", Statutes 1931, page 910, in effect August 14, 1931, require that the public body awarding any contract for public work on behalf of any city shall ascertain the prevailing rate of per diem wages in the locality in which the work is to be performed for each craft or type of laborers, workmen or mechanic needed to execute the contract, etcetera; and

WHEREAS, under the said Loan and Grant Agreement the maximum hours per day that any of said laborers, workmen or mechanics can be employed is eight (8) hours, and in any one (1) week a maximum of thirty (30) hours; and under Section 653c-1 of Park 1, Title 15, Chapter 2 of the Penal Code of the State of California the maximum hours per calendar week that any of said laborers, workmen or mechanics can be employed is thirty (30) hours; and

WHEREAS, in said Loan and Grant Agreement it is provided that certain minimum hourly wages shall be paid; and

WHEREAS, the Council of the City of Chula Vista, California has ascertained the general prevailing rate and general legal holiday and overtime rate of per diem wages in the City of Chula Vista, California for each craft or type of laborer, workman or mechanic needed in the aforesaid paving project,

NOW, THEREFORE, BE IT RESOLVED, and this Council hereby declares, that the general prevailing rate of per diem wages in the City of Chula Vista, California for a day of eight (8) hours for each craft or type of laborer, workman or mechanic needed to execute said work, is as follows, to-wit:

That the hourly wage of each and all of the aforesaid laborers, workmen and mechanics is one-eighth of the respective amount in each of said classifications; and

That the legal holiday and overtime general prevailing rate of wages in the said City is one and one-half times the respective hourly rates aforesaid; and

That all skilled labor employed in said public works project shall receive not less than the sum of One and 10/100 Dollars (\$1.10) per hour, and all unskilled labor not less than the respective hourly rate ascertained herein.

That Resolution No. 389 of the City Council of the City of Chula Vista, California, passed and adopted January 29, 1935, be and the same is hereby rescinded.
