RESOLUTION NO. 413

OF THE CITY COUNCIL OF THE CITY OF CHULA VISTA, CALIFORNIA,
APPROVING ENGINEERS' PAVING PROJECT REPORT AND REQUESTING
P.W.A. ENGINEER FOR THE STATE OF CALIFORNIA TO AUTHORIZE
AWARDING OF CONTRACT BY CITY.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHULA VISTA, CALIFORNIA:

1. That the engineers' report of Allen & Rowe, engineers for the City of Chula Vista, California, which engineers' report is dated July 15, 1935 addressed to the Honorable Mayor and City Council of Chula Vista, California relative to the paving project for the City of Chula Vista, California, commonly known and described as P.W.A. Docket 8025; and which engineers' report is on file in the office of the City Clerk of said City and numbered 416; BE AND THE SAME IS HEREBY ADOPTED AND APPROVED;

2. That the City Council of the City of Chula Vista, California request, and it does hereby request, the P.W.A. Engineer for the State of California to authorize the City of Chula Vista, California to award the contract for the said paving project to the V. R. Dennis Construction Company in accordance with the recommendations contained in said City Engineers' report;

3. That the said City Engineers be and they are hereby authorized and directed to forthwith transmit to the said P.W.A. Engineer, Washington Building, Los Angeles, California, the following documents certified by the City Clerk of said City:

- (1) The necessary number of certified copies of this Resolution;
- (2) One certified copy of said Engineers' Report, the original of which is now on file with the City Clerk of said City, numbered 416;
- (3) Four (4) certified copies of a Tabulation of Bids received for said paving project, the originals of which are now on file with the City Clerk of said City, numbered 416;
- (4) One certified copy of a signed statement from each of the three lowest bidders showing their financial responsibility and technical qualifications, the originals of which are now on file with the City Clerk of said City, numbered 416;
- (5) One certified copy of the Proposal or Bid of each of the said three lowest bidders, the originals of which are now on file with the City Clerk of said City, numbered 416.
