

RESOLUTION No. 448
Providing for Special Election regarding Purchase of Recreation Park

Whereas, The Chula Vista Union Grammar School District is the owner of Lot 17 of Quarter Section 137 of Rancho de La Nacion, in the City of Chula Vista, Chunty of San Diego, State of California, and which property is located at the Southeast Corner of 2d Avenue and E Street, in said City, and consists of 5 acres more or less; and

Whereas, the Board of Trustees of said School District have indicated their willingness to sell, subject to law, said property to the City of Chula Vista, California, for the purpose of a play-ground and-recreation center for a sum approximating \$2500; and

Whereas, the City Council of said City has not now on had funds available for the purchase of said property; and

Whereas, said Council believes that the most practicable manner of acquiring said property would be by procuring funds therefor from the general taxes of said City of the fiscal year 1936-1937; ~~proposed~~ and *be done*

Whereas, said Council believes that the matter of acquiring such property by said City with funds as aforesaid *only* upon approval of the electors of the said City; and

Whereas, a special election can be economically held on the ___ day of August 1936 whereby the said electors of said City can so decide;

Now, Therefore, be it Resolved by the CC of the CCVC, as follows, to wit:

First: That a special election be, and it is hereby called to be held in the CCVC on Tuesday, the ___ day of August 1936;

Second: That the proposition of said election be: Shall the CCVC expend the sum of ~~\$25~~ \$2500 for the acquisition from the CV Union Grammar School District of Lot 17 of Quarter Section 137 of Rancho de la Nacion, in the City of Chula Vista, County of San Diego, State of California, as a recreation center; said sum to be ~~procured~~ paid from the general tax for the fiscal year 1936-1937;

Third: That there shall be 8 voting precincts for the purpose of holding said election consisting of the regular election precincts established for holding the State and County elections on the ___ day of August 1936, and the polling places thereof shall be the same as for said State and County Election;

Fourth: That the officers for said precincts shall be the same as for said State and County Election;

Fifth: That the City Clerk is hereby directed to publish notice/of said special election in one issue of the Chula Vista Star, a newspaper published and of general circulation in the CCVC, and to perform such other duties in connection therewith as may be prescribed by law.
