

RESOLUTION No. 454.

A RESOLUTION OF THE CITY OF CHULA VISTA, CALIFORNIA, CANVASSING THE SPECIAL ELECTION HELD IN SAID CITY, ON TUESDAY, THE 25th DAY OF AUGUST, 1936, FOR THE PURPOSE OF VOTING UPON THE PROPOSITION OF EXPENDING THE SUM OF \$2500.00 FOR THE ACQUISITION FROM THE CHULA VISTA GRAMMAR SCHOOL DISTRICT OF LOT 17 OF QUARTER SECTION 137 OF RANCHO DE LA NACION, IN THE CITY OF CHULA VISTA, COUNTY OF SAN DIEGO STATE OF CALIFORNIA AS A PLAYGROUND AND RECREATION PARK, SAID SUM TO BE PAID FROM THE GENERAL TAX FOR THE FISCAL YEAR 1936-1937.

WHEREAS, the City Council of the City of Chula Vista, California, did at a regular meeting thereof held on the 22d day of July 1936 by a vote of more than two-thirds of all its members, duly and regularly pass and adopt Resolution No. 452, of said City, ordering calling and providing for the holding of a special election to be held in the City of Chula Vista, on Tuesday, the 25th day of August 1936, for the purpose of submitting to the qualified electors of said City a proposition for the acquisition of Lot 17 of Quarter Section 137 of Rancho de la Nacion, in the City of Chula Vista, County of San Diego, State of California, as a playground and recreation Part; and

WHEREAS, it appears that notice of said election was duly and regularly given and that said election was duly and regularly held as required by law; and that in all respects said election was held and conducted, and the votes cast thereat, received and canvassed and the returns thereof made and declared, in the time, form and manner as required by law; and

WHEREAS, the City Council of the City of Chula Vista, California, has met at the Council Chambers of said City, in the City Hall, on Monday the 31st day of August 1936, to canvas the returns of said election;

NOW, THEREFORE, the City Council of the City of Chula Vista, California, does resolve, find, determine and declare as follows:

Section 1. That said special election was held and conducted in said City of Chula Vista, California, on Tuesday the 25th day of August 1936, in time, form and manner as required by law;

Section 2. That the proposition submitted at said election was as follows:
"Shall the City of Chula Vista, California, expend the sum of \$2500 for the acquisition from the Chula Vista Grammar School District of Lot 17 of Quarter Section 137 of Rancho de la Nacion, in the City of Chula Vista, County of San Diego, State of California as a playground and Recreation Park, said sum to be paid from the general tax for the fiscal year 1936-1937?"

Section 3. That there were 8 election precincts for said special election; that the total number of votes cast at said election was 1037; that the total number of votes cast for and against said proposition at each precinct was as follows:

That the total vote cast in favor of said proposition at said election was 584; that the total vote cast against said proposition at said election was 453.

Section 4. That the City Council of said City does hereby find, determine and declare that more than a majority of the qualified voters voting on said proposition at said election voted in favor of said proposition.
