

RESOLUTION NO. 463

BID ON CHULA VISTA UNION SCHOOL DISTRICT PROPERTY FOR  
PLAYGROUND AND RECREATION PARK

WHEREAS, there was duly and regularly held within the City of Chula Vista, California a special election on the 25th day of August, 1936 for the purpose of voting upon the proposition of expending the sum of \$2,500 for the acquisition from the Chula Vista Union School District of Lot 17 of Quarter Section 137 of Rancho de la Nacion in said City as a Playground and Recreation park for said City; and

WHEREAS, at said special election the said proposal for said purchase of said land was approved by the qualified electors voting on said proposition; and

WHEREAS, the said sum of \$2,500 for the said proposed purchase was included in the budget of said City for the fiscal year 1936-1937 and which sum is now available for said purpose; and

WHEREAS, the Chula Vista Union School District has invited bids for the purchase of said property for a sum of not less than \$2,500, said sum to be payable one-half in cash upon execution of contract of sale, and the balance in cash not later than April 15, 1937, said bids or sealed proposals to be presented on or before 7:30 o'clock p.m. of December 14, 1936, at which time said bids or sealed proposals will be opened by the said District's Board of Trustees at the Chula Vista Union School House at Second Avenue and F Street in said City; and

WHEREAS, said bid or proposals must be accompanied by an unconditional certified check for an amount not less than ten per cent of the bid price; and

WHEREAS, it is the desire of this Council to bid the sum of \$2,500 on said property, said sum to be paid in cash in one payment, or in such other form as the said District may require;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHULA VISTA, CALIFORNIA, as follows, to-wit:

That the City of Chula Vista, California, do and it does hereby, by and through this Body, propose to purchase from the Chula Vista Union School District said property as a Playground and Recreation Park for the sum of \$2,500 cash, payable at such time as the said District may require;

That the City Clerk of said City be and he is hereby instructed to transmit to the proper officer of the governing body of said School District a certified copy of this Resolution, properly sealed, to be delivered on or before the said time of opening of said bids, together with a letter informing said Officer of said District that said certified copy of this Resolution be and the same is its bid on said property;

That a warrant be drawn forthwith in the sum of \$25000 on the funds of said City, payable to the Bank of America National Trust & Savings Association, Chula Vista Branch, with which said Clerk shall procure a cashier's check in such amount in favor of the Chula Vista Union School District, and which check shall be transmitted with said bid.
