OF THE CITY COUNCIL OF THE CITY OF CHULA VISTA, CALIFORNIA, ACCEPTING LANDS FROM C. R. HANAN AND NEOMA A. HANAN, ROBERT MARSH AND CHRISTENA MARSH, MURRAY CAMPBELL AND EFFIE H. CAMPBELL, STENOLAUS WISTLESON A SINGLE MAN, MANTIE MONTGOMERY A SINGLE WOMAN AND FRANCES M. ALLEN A SINGLE WOMAN; RONALD M. LIVINGSTON AND IDA FAE LIVINGSTON.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHULA VISTA, CALIFORNIA;

That that certain quit-claim deed dated March 29th, 1937 executed and delivered by C. R. Hanan and Neoma A. Hanan, as grantors, to the City of Chula Vista, California, grantee, of the property described as follows, to-wit;

That portion of Lot 6 in Quarter Section 137 of Chula Vista, in the City of Chula Vista, County of San Diego, State of California, according to the Map thereof No. 505, filed in the office of the Recorder of said County, March 13, 1933 and more particularly described as the Easterly 10.86 feet of the Easterly 136.72 feet of the Northerly 100 feet of Lot 6.

That that certain quit-claim deed dated April 5th, 1937 executed and delivered by Robert Nathaniel Marsh and Christena Marsh, as grantors, to the City of Chula Vista, California, grantee, of the property described as follows, to-wit;

That portion of Lot 6 in Quarter Section 137 of Chula Vista, in the City of Chula Vista, County of San Diego, State of California, according to the Map thereof No. 505, filed in the office of the Recorder of said County, March 13, 1933 and more particularly described as the Easterly 9.14 feet of the Easterly 125 feet of the Easterly 201.72 feet of the Northerly 100 feet of Lot 6.

That that certain quit-claim deed dated April 28th, 1937 executed and delivered by Mantie Montgomery, a single woman, as grantor, to the City of Chula Vista, California, grantee, of the property described as follows, to-wit;

That portion of Lot 6 in Quarter Section 137 of Chula Vista, in the City of Chula Vista, County of San Diego, State of California, according to the Map thereof No. 505, filed in the office of the Recorder of said County, March 13, 1933 and more particularly described as the Easterly 10 feet of the Easterly 125.62 feet of the Easterly 261.64 feet of the Northerly 66 feet of the Southerly 132.2 feet of Lot 6 above described.

That that certain quit-claim deed dated March 8th, 1957 executed and delivered by Frances M. Allen, a single woman as grantor, to the City of Chula Vista, California, as grantee, of the property described as follows, to-wit;

The Easterly ten (10) feet of the Westerly 135.87 feet of the Eortherly Sixty-six feet of five (5) acre lot six(6), Quarter Section 137, Rancho de la Nacion, and are, and each of them is hereby approved and accepted by the City Council of said City of Chula Vista, California, for and on behalf of said City of Chula Vista, California:

That each and all of said property, is granted for alley purposes, and as a dedication thereof for such purposes, and as a part of the alley running Eortherly and Southerly through the Ratcliffe Tract in said city and to be a part thereof between E street and Davidson Street, and each and all of said property is declared to be a part of said alley and its extension southerly in said City of Chula Vista, California, in fact and in name.
