OF THE CITY COUNCIL OF THE CITY OF CHULA VISTA, CALIFORNIA, ACCEPTING LANDS FROM CHARLES E. SMITH AND FAY JORDAN SMITH, AND POMONA MUTUAL BUILDING AND LOAN ASSOCIATION, A CORPORATION.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHULA VISTA, CALIFORNIA.

That that certain quit-claim deed dated May 13th, 1937 executed and delivered by Charles E. Smith and Fay Jordan Smith as grantors, to the City of Chula Vista, California, grantee of the property described as follows to-wit;

That portion of Lot 6 in Quarter Section 137 of Chula Vista, in the city of Chula Vista, County of San Diego, State of California, according to the Map thereof No. 505, filed in the office of the Recorder of said County, March 13, 1888 and more particularly described as the Westerly 10.05 feet of the Easterly 125.82 feet of the Westerly 261.64 feet of the Northerly 50 feet of the Southerly 182.2 feet of Lot 6.

That that certain quit-claim deed dated May 6th 1937 executed and delivered by the Pomona Mutual Building and Loan Association, a corporation, as grantors, to the City of Chula Vista, California, as grantee, of the property described as follows, to-wit;
