

RESOLUTION NO. 502

Accident and Sickness Insurance for Employees of the City of Chula Vista from The Travelers Insurance Company

WHEREAS, all of the eligible employees of the City of Chula Vista, California, have signified in writing their desire to participate in a plan of group accident and sickness insurance at their own expense; and

WHEREAS, The Travelers Insurance Company, of Hartford, Connecticut, by and through R. W. Merrill, its Agent, has submitted a Plan whereby such accident and sickness insurance can be procured for said Employees by the said City making application therefor, and, when and if such insurance be procured, make premium deductions from the pay of said City employees on the payroll thereof; and

WHEREAS, written requests for all such City employees so eligible have been filed with the City Clerk of said City authorizing said deductions to be made; and

WHEREAS, said Plan of said Insurance, as more fully set forth in a certain letter dated October 29 1937 addressed to the City Council of said City, and signed by R. W. Merrill, as Agent for said The Travelers Insurance Company, as on file with the said Clerk and the contents thereof communicated to said City Council, appears to be beneficial to said Employees and will be to the best interests of said City if said Plan be put into effect;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHULA VISTA, CALIFORNIA, AS FOLLOWS, TO-WIT:

That said Group Insurance Plan be, and the same is, hereby approved;

That the Mayor of said City be and he is hereby authorized and directed to make formal application for and on behalf of said City to The Travelers Insurance Company, of Hartford, Connecticut, for such an Insurance Contract as incorporates said Plan of Insurance therein; which Application shall be in form as set forth on the Application Form attached hereto and hereby made a part hereof;

That said Insurance shall, subject to the approval of said Insurance Company, become effect as of the First day of December 1937;

That the City Clerk shall forthwith pay to the said Insurance Company, upon delivery of said Application executed as aforesaid, the sum of \$24.50, which amount is the first monthly premium on said Group Insurance;

That the deductions from each of said eligible employees pay so insured on the November 15 1937 payroll of said City, which are the respective amounts as set forth in said letter from said Insurance Company agent, and which amounts in the aggregate total \$24.50, be and the same are hereby approved;

That when the Insurance Policy Contract for said Insurance has been received by said Clerk from the said Insurance Company, he shall then and thereafter make the required premium deductions from said eligible employees so protected on the mid-month payroll of said City, beginning with the month of January 1938;

That then and thereafter the monthly premiums shall be paid by said City in accordance with said Insurance Contract, with accounting between said Insurer and said City as to over-payment or under-payment of said monthly premiums, as the case may be, to be made each quarter-year from and after December 1 1937.
